Due to any reason such as Covid 19 or any other occurrence that City, State or Federal authorities shut down public gatherings. We the ACLS nor its Directors will be held liable for not having an annual Stock Show. Just because animals or projects are entered to show does not guarantee a Show. In the event this should occur all entry monies will be returned.

ENTRY REGULATIONS

Exhibitors are limited to 4 entries per species except broilers & rabbits will be limited to 2 pens at the Atascosa County Livestock Show.

Entering any other county Livestock Show shall constitute automatic disqualification from the Atascosa County Livestock Show. This rule also pertains to Ag Mechanics Projects.

LATE ENTRIES: Late Entries will be accepted up until December 20th at **DOUBLE THE ENTRY FEE**. After December 20th, an **ENTRY FEE of \$200.00** will be accepted up until one hour prior to the official sift/weigh-in or breeding paper check in of the species (this includes Showmanship, Skillathon and Ag Mechanic Entries).

☐ **SALE LINEUP:** I acknowledge & agree that if my child places & makes the premium sale, he or she must report to the committeeman in charge of the auction lineup in the designated area at least 15 sale lots ahead of his or her lot number. If my child fails to report at least 15 sale lots ahead of his or her lot number, he or she will forfeit the right to sell his or her project & will be removed from the sale list altogether. **Only the Selling Exhibitor will be allowed on Stage. If an exhibitor is not at the sale, a Sale Absence Form must be submitted and approved. Absent Exhibitors may submit a Poster/Sign to be displayed and a brief writeup of why they are not at the Auction.**

☐ **THANK YOU LETTERS:** Thank you letters are required from all exhibitors of all buyers, add-on supporters and sponsors of awards for all divisions. All 4-H and FFA members are required to turn in their original thank you letter in an unsealed, addressed and **STAMPED** envelope to their respective Ag Science Teacher or the 4-H Extension Office. Until letters are written and approved by their respective Ag Science Teacher or 4-H Extension Office, the exhibitors check will be withheld.
